 - 5.1 Carl Hampton commented on the EMR/EMT courses offered on the Chino campus by Chaffey College.
- 6. Consent items- None
- 7. Legislative Update- Santiago Jackson reported on recent legislation solidifying the requirement of the separation of AEBG adult education funds from district funds and that adult education funds are to be expended for adult education purposes only. \$500 million has been approved in the state budget for 17-18 and an emphasis has been place on on-going for adult education and removal of the term "grant" from state budgetary allocations for adult education.
- 8. Deliverable Information and updates as reported by Todd Haag-
 - 8.1 Data- letter from State AEBG was distributed indicating that End of Year Data and Fourth Quarter AEBG Data Integrity Report (DIR) are due from individual members by August 1st
 - 8.2 Expense, Activities & Progress Reports for 2015-16 & 2016-17 are due July 31st and will be produced and submitted by consortium lead and fiscal agent.
 - 8.3 17-18 Plan is due August 15th, and as disclosed at the CASAS Summer Institute, will to be more general in nature/consortium big picture per updated & distributed template.
 - 8.4 Accounting and reporting of activities and expenditures is going through some changes with more detail being requested from individual consortium agencies and a new template is scheduled for release in October and webinars and training sessions to be provided.
 - 8.5 Neil Kelly is negotiating for an extension of the use of the Data/Accountability Plan funds for another year, from 12/17 to 6/18. This with respect to much uncertainty regarding state and federal data mandates and consortiums being able to make the best use of the funds.

- 8.6 Jay Wright from CASAS recently indicated that the feds are beginning to realize that the "data match" for determining outcomes is problematic and would not accurately reflect program success. It is believed that items 8.4-8.6 above have materialized, to some extent, via the efforts of the recently created AEBG "Field Teams".
- 8.7 The Sacramento County Office of Ed has a new and more prominent role in with regard to the AEBG website, professional development/training and data and reporting for AEBG.
- 8.8 Chris Nelson, previous head of adult education at the state has returned to the Oakland, CA adult education program. The new head is Dr. Carolyn Zachry
